CEN-CLC Focus Group on Artificial Intelligence

Proposed time schedule “towards the CEN-CLC technical Roadmap”

BACKGROUND

By decisions BT C183/2018 and D161/C069, the CEN and CENELEC BTs decided to establish a CEN-CENELEC Focus Group on Artificial Intelligence (AI) and invited interested NSBs/NCs to apply for the secretariat and for the convenorship.

This follows the Stakeholders’ engagement workshop on AI organized in September 2018, during which it was announced that CEN and CENELEC will communicate the European standardization roadmap for AI.

The time schedule “towards the CEN-CENELEC roadmap for AI standardization” attached, has been discussed at the CEN-CLC/BTWG 6 plenary meeting on 2019-01-22. CEN-CLC/BTWG 6 recommends the BTs to endorse this time schedule, so that it can be presented as a CEN-CENELEC document in the upcoming communication activities around AI.

 - decisions C183/2018 and D161/C069 on the establishment of a joint CEN-CLC Focus Group on AI;
 - the outcomes of the Stakeholders’ engagement workshop on AI, according to which CEN-CLC should communicate their upcoming activities on AI standardization in Europe;
- decided to endorse the time schedule “towards the CEN-CENELEC roadmap for AI standardization” as included in Annex to BT N 11454 and BT161/DG11173/DC;
- asked CCMC to communicate this time schedule to the CEN-CLC Focus Group on AI, once established, as the framework for the upcoming CEN-CLC technical roadmap on AI standardization.

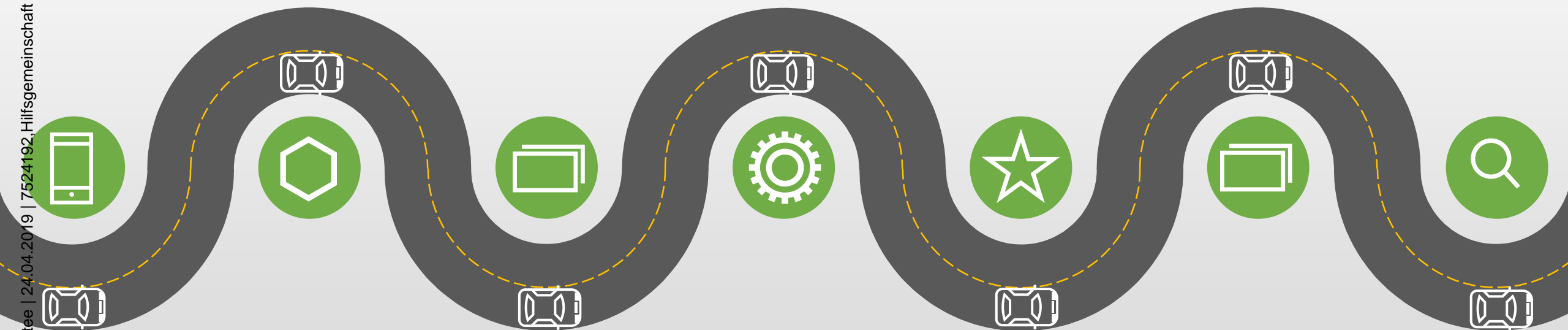
